SOUTHERN CALIFORNIA CUSTOMERS

Effective April 1, 2021, Southwest Gas is authorized to adjust natural gas rates for its California customers (General Rate Case Application (A.) 19-08-015). This results in an overall increase in annual revenues of \$3 million or 2.7 percent in Southwest Gas' Southern California service territory.

To minimize bill volatility for residential customers, the Basic Service Charge has been increased and the number of residential baseline seasons increased from two to three:

Season	Months for Customers in Barstow, Needles, and Victorville:	Months for Customers in Big Bear:
Summer	May-October	June-October
Spring/Fall - <i>New</i> (<i>Winter Off-Peak</i>)	March, April and November	April, May and November
Winter	December-February	December-March

Monthly bills that reflect usage both prior to and after the effective date of the rate change will be billed the old rates for the usage prior to the effective date and the new rates for the usage after the effective date.
